1. Locate explicit textual information, draw complex inferences, and describe, analyze, and evaluate the information within and across multiple texts of varying lengths
2. Comprehend and use vocabulary effectively in oral communication, reading, and writing.
3. Identify and analyze the audience, purpose, and message across a variety of texts.
4. Describe and apply insights gained from reading and writing a variety of texts.
5. Compose a variety of texts that demonstrate reading comprehension, clear focus, logical development of ideas, and use of appropriate language that advance the writer's purpose.
6. Determine and use effective approaches and rhetorical strategies for given reading and writing situations.
7. Generate ideas and gather information relevant to the topic and purpose, incorporating the ideas and words of other writers in student writing using established strategies.
8. Evaluate relevance and quality of ideas and information in recognizing, formulating, and developing a claim.
9. Develop and use effective reading and revision strategies to strengthen the writer's ability to compose college-level writing assignments.
10. Recognize and apply the conventions of Standard English in reading and writing.

STUDENT EXPECTED TIME REQUIREMENT

Grade Calculations for Khan Academy are as follows:

If the due date for a Unit has passed, and I see any exercises coded as "attempted" or "missed" or "in progress" a "zero" will be averaged in for those assignments, if there is not a numeric grade posted for those exercises in Khan. I will input your grades in the 0173 gradebook for each of the 4 units after their "due dates". Do not expect to see immediate grade averages, as it will take me a few days to complete those averages. To view these exercises, and the "due dates", scroll up to the lab assignment schedule above please. Each Unit's exercises will be an "average" of that entire unit's exercises divided by the number of exercises in the unit. I will do this by hand calculation and keep a written record of each Unit average grade for all students. The Unit tests will be calculated as an average by themselves and are in the 25% category. I will send an announcement when I have populated each unit's averages into the 0173 gradebook. Keep in mind, it is your responsibility also to check your scores, in your student dashboard, and average them out yourselves, to make sure the averages posted in 0173 are correct.

Zeros will be placed in assignment areas which exceed the "due dates"; however, students need to message me or email me upon completion of late unit assignments, so I can post completed grades when the entire unit is completed.
