COURSE DESCRIPTION

This course covers the preparation of structural steel drawings and bills of material for the purpose of fabrication and erection. Emphasis will be placed upon using structural design framing plans to develop detailed steel members, connections and assemblies.

COURSE OBJECTIVES

Upon completion of this course, the student will be able to

1. Use AISC, ASD, LRFD, and OSHA standards
2. Interpret and draw design / erection drawing
3. Detail structural beams from a design drawing
4. Detail structural columns from a design drawing
5. Detail structural platforms with flooring, handrail, ladder and stairs
